## Clarifying the facts on what a Funtley Parish Council can do

We would like to add a little clarity to Fareham Borough Council's (FBC) questionnaire and information, which you have recently received. You may have read in this document regarding the powers of a Parish Council Campaign, that *"these functions can only be carried out if they are delegated to the parish by the Borough Council."*

We must say that it could have been worded a bit better. However as Fareham Borough Council have never had to set up a Parish or Village council before, we put their choice of words down to naiveté rather than any deliberate machination.....

Parish Councils can act within restraints set out (mainly) by the Local Government Act 1972 and its successors, including the Localism Act 2011.

As there are a few legal duties, the precept charge will depend on what Funtley actually wants and needs, both immediately and in the future... **our (precept) money stays in and is spent in our parish. Parish councils also have a lot of powers, none constrained by its principal authority. The parish is not beholden to the principal authority, nor are functions delegated** (source: Steven Lugg, Chief Executive, Hampshire Association of Local Councils, 28.09.15).

As stated in our Autumn Newsletter, a Parish Council will have influence and input on planning, traffic calming measures,

## SAY YES TO A FUNTLEY PARISH COUNCIL

footpaths, street lighting, leisure and sports facilities .....

A Funtley Parish Council will only take on duties that we decide we want to take on. Fareham Borough Council cannot force us to take on tasks such as grass cutting, replacing bins and so on. Any duties we as a community decide to take on, will be **IN ADDITION** to existing services supplied and facilitated at present by Fareham Borough Council, as we're already paying for these services. If, of course Fareham Borough Council, would like a Funtley Parish Council to take on additional "presently supplied" or in their words "delegated services", then along with the delegated service, a pot of money **WOULD HAVE TO FOLLOW** from the council to do this, as this service has already been paid for in your council tax. We as council tax payers in Fareham Borough, should not be discriminated against or be at a financial disadvantage compared to our fellow tax payers within the whole of Fareham Borough.

The precept we have suggested is set according to a prospective Funtley Parish Council plan. All precept monies raised have to be spent providing services and amenities only in Funtley.

You do not need to give written reasons why you do or don't want a Funtley Parish Council. A simple yes (or no) tick in the boxes is sufficient. **So please tick the YES box** on the council's questionnaire and return it.

If you have misplaced your questionnaire or did not receive one, please contact us and we'll organise a replacement.
